Subject: Tax Year 2024 1099s for Companies using Sage X3 ERP

Overview:

The Internal Revenue Service (“IRS”) requires 1099s to be completed by specific dates each year. This memo reviews important details of 1099s and what you need to know to complete your 1099s with Sage X3 ERP.

Critical Due Dates:

You are required to deliver 1099s to the recipients by January 31, 2025.

You are required to file 1099-NECs (Non-Employee Compensation) with the IRS by January 31, 2025.

You are required to file all 1099-MISC, 1099-INT and 1099-DIV with IRS by February 28, 2025.

Most filing services require processing to be done 3 days prior, though some will allow it later for an additional fee.

NOTE:

- IF YOU USE CREDIT CARDS TO PAY YOUR VENDORS YOU DO NOT HAVE TO ISSUE 1099S

What to Know for Tax Year 2024:

The IRS has not made any significant changes to 1099 reporting for Tax Year 2024. This means that if you have updated your Sage X3 ERP software in past years, you will most likely not need to apply an update to support generating 1099 information.



Important information about 1099s and Sage X3 ERP

Sage will not be releasing any downloads for 1099 updates this year.

The Sage X3 version 12.0.1099 2022 cumulative patch update includes fixes previously delivered, as well as the new 2022 1099/1096 tax reporting changes.

The 1099 2022 update is only for Sage X3 release 2019 R5 (12.0.20) and above. This update is included in 2023 R1 (12.0.33).

Overview:

Sage X3 tracks 1099 information for the following:

- 1099-NEC (Nonemployee Compensation)
- 1099-MISC (Miscellaneous Income)
- 1099-DIV (Dividends and Distributions)
- 1099-INT (Interest Income)

Sage X3 prints the following 1099 forms:

- 1099-NEC
- 1099-MISC
- 1096 summary for NEC and MISC forms

Use Crystal Reports to adjust the 1099 forms to print. If you need assistance with Crystal Reports, please email support@rklesolutions.com and create a new support request.

Today, the primary methods for completing 1099 reporting for users of Sage X3 ERP are the following:

- Export of 1099 Data for upload to a 1099 Processing Service
 - This has become the preferred approach of most Sage X3 ERP clients. This approach removes many of the challenges that go along with completing the installation of updates against Sage X3.
 - This approach can be utilized by any company that is using Sage X3 ERP.
 - There are many companies that can be used for 1099 reporting – like Aatrix – which allow you to upload your data for processing.
 - Generate a CSV or Excel format file from the 1099 query function in Sage X3.
 - The file can be manipulated to use with 3rd party electronic reporting software

Changes for 2024 Form 1099-MISC:

No specific changes to be noted for Tax Year 2024.
